

PRIVACY POLICY

We are completely committed to respecting and maintaining user privacy on the Mr Park website. We have therefore designed this Privacy Policy to describe to you the use of your private personal information provided to us when you use our website. By accessing or/and using our website, you explicitly consent and agree to be legally bound by the terms of this Privacy Policy. If you are not in full agreement with our policy, you should not use or access our website.

Your acceptance of this Privacy Policy signifies your consent to the way we use and disclose your personal information as stated in the policy.

• INFORMATION WE COLLECT

Detailed below are the different kinds of information that we collect from users:

- Registration information: This is information provided by you to us during the registration process. This may include name, physical address, email address, telephone and/or mobile phone number.
- Any other additional information that we may ask you to provide (as the case may arise) in order to verify your identity or other information pertaining to your account.
- Information obtained by Mr. Park through user reviews, user ratings, and chats.
- Information that you submit to Mr Park in the form of comments, messages to other users or contributions to discussions.
- Routinely collected information: We may also gather general information based on your activities when you use Mr Park. This type of information includes what areas of the website you visit and what services you access. Our servers also routinely collect information about your computer hardware and software such as IP address, domain names, browser type, access times and referring Web site addresses. Please note that such details are not linked to your personal information. Rather, this information is primarily used to conduct research on user demographics, behavior and interests.

• HOW WE USE YOUR INFORMATION

We use the information that we gather on Mr Park, whether personal, demographic, collective or technical, for the following purposes:

- To create and administer your account, and to deliver the services that we offer;

- To ensure the security of your account;
- To improve and enhance the delivery of our Services;
- To prevent fraud;
- To process any request for advice or information;
- For research purposes;

- To contact you when necessary; and

- **HOW AND WHY WE MAY SHARE YOUR INFORMATION**

We may divulge your personal information (in response to a subpoena, a similar investigative demand, or a court order) to the relevant legal authorities/government officials if compelled to do so.

Excluding the aforementioned, we will never deliberately sell, exchange or otherwise give your personal information to third parties.

- **USE OF OUR SITE BY MINORS**

We have designed our website and services for use by an adult audience only. As such, minors (individuals less than 18 years) are not eligible to use our website. If you are a minor, you may only use this website in conjunction with and under the supervision of parents or guardians.

Please note that we will never intentionally collect personal information from minors under the age of 18.
